The key to success is data governance.


You too can become data literate

- 2. You're the person using the data to provide insights to your stakeholders.





Two different data journeys


The professional services firm

- 2. The solution was available for PC and Tablet









The need for Data Governance

Starting with Data Governance

- 1. Data Governance may not be the correct starting point for your data management journey.

 - What are your data needs?
 - · What do you need to govern?
 - Can you use the data you already have?
- 3. And most importantly **WHY** do you need to govern your data?



Data Management is the development and execution of plans, policies, practices and projects that acquire, control, protect, deliver and enhance the value of data.


